The remaining option will be to simply send me an e-mail at tret604@yahoo.com with the names of the members you are nominating and the position you are nominating them for. This manner of nominating is also due to me by September 30, 2010.

Regardless of how you choose to make your nominations, you are encouraged to do so.

General Requirements:

Nominations will be accepted for the four Officer positions, (President, Vice President, Treasure and Secretary), and up to 15 Directors to serve on the Downriver Walleye Federation (DWF) Board Of Directors for the 2011 calendar year.

All qualified nominees will have their names placed on a ballot, and a general election will take place at the October 2010 DWF membership meeting. Please review the following criteria before completing the nomination form.

Only DWF “members in good standing” can nominate candidates for positions as
Officers or the DWF Board of Directors.

Only DWF “members in good standing” will be accepted as candidates for positions as
Officers or the Board of Directors.

Any DWF “member in good standing” (including current Officers and Directors) may nominate any DWF member (including themselves) for the positions to be voted for.

A written description of the duties and responsibilities of each Officers position is included in the DWF By-Laws. (*See a Board Member for a copy Also available on the DWF Web site.*)

Members can make nominations for any or all of the Officer positions (*Example: You may nominate a member for President, but leave the other three candidate fields blank*).

Only one nomination form per member will be accepted.

Prior to preparation of the ballots, all nominations will be reviewed by the current Election Committee, for the elections of Officers and Board Members in October of 2010. If, for any reason, a candidate is disqualified from the ballot, that nominee will be notified immediately by the Election Committee and a record of the proceeding will be made available to the entire membership upon request.

All nominees will be contacted in person to verify that they are willing to accept the responsibilities of the position they have been nominated for if they are elected. Any nominee not willing to accept the position will not be on the ballot.

Notice of Nominations:

It is critical to the operation of the Downriver Walleye Federation that we have nominations for all Officers and Directors to guide the DWF in 2011. The terms of the officers (President-Vice President - Secretary - and Treasurer) as well as the Board of Directors (up to fifteen) are for one year terms and are due to expire on January 1, 2011. Without nominations and candidates, the DWF cannot exist. In order to make it easier for you to nominate someone, you can do it by simply filling out the form included here in the newsletter and SUBMITTING it before September 30, 2010.

There is also a nominations form available to those who have computers on the DWF web site. Just fill it out with your nominations and click on submit.

Whichever way you choose to use, please do make every effort to do it. You don't have to have a nomination for every single position but it is wise to at least nominate the ones you are hoping to see in office in 2011. You do not need the nominee's permission to nominate him/her. You need only to make the nomination and then there will be a process of asking the nominee's if they accept or decline the nomination. After that, only those who accept their nomination will be placed on a voting ballot for the membership to cast their individual choices from those who are running for an Office or a place on the Board of Directors.

Forms MUST be submitted by September 30, 2010

The Election Committee

The Election Committee shall oversee all of the election process and will govern the nominations and voting throughout the voting process.

The election committee shall consist of it's chairperson and any assisting members chosen by the chairperson or the DWF President.

For the election of the 2011 Officers and Board of Directors, the Chairperson will be Terry Pickard.
